Materials Body: New 2.0 transparent or mass-dyed polycarbonate, a material that uses renewable feedstock from the pulp and paper industry in the synthesis phase. The process used for the production of the material is ISCC certified* (International Sustainability and Carbon Certification);

Light bulb: 110V • MAX 4W LED • 60 Hz E14

Note: this product datasheet complies with the provisions of the law governing "Consumer Information" envisaged by Legislative Decree no. 206 of 6 September 2005 (Consumer Code), supplementing and/or replacing Law no. 126 of 10 April 1991 on "Consumer Information Regulations", as well as Decree no. 101 of 8 February 1997 "Implementing Regulations".
